II. Eligibility for application(Identity & language)

1. Qualifications for application

- A. Applicants who are eligible for admission through the special admission program for foreigners
 - Both the applicant and his/her parents should be foreigners.
 - If you acquire alien status later due to a change in nationality, you will not be eligible.
 - Korean nationals with multiple nationalities are not eligible.
- B. Regular school graduates
 - Those who have graduated(or are expected to graduate) from a domestic or foreign high school course or higher
 - A person who has completed at least 12 years of school curriculum equivalent to elementary, middle, and higher education in Korea abroad.
 - If you have received training in two or more countries, the total training period must be at least 12 years.
 - Educational background such as domestic or foreign high school qualification exam, home schooling, cyber learning, etc. are not recognized.
- C. Language Proficiency is required
 - Those who have level 3 or higher in the Test of Proficiency in Korean (TOPIK) (level 2 or higher in arts and physical education)
 - ※ In addition to TOPIK, the Ministry of Justice's Social Integration Program and King Sejong Institute Korean standards are additionally recognized.
 - ※ In addition to TOPIK, the Ministry of Justice's Social Integration Program and Sejong Institute Korean language standards are also accepted.
 - Ministry of Justice Social Integration Program: (Freshman students) Completion of Step 3 or score of 61 or higher in pre-assessment
 - King Sejong Institute Korean standard: (Freshman) Completion of Intermediate Level 1
- D. Applicants with documents and supporting materials
- E. Applicants who meet the application qualifications set forth in the university's foreign recruitment guidelines
- F. Applicants who apply more than 6 times during rolling admissions(undergraduate courses) may have their applications canceled.
- G. Transfer applicants
 - Undergraduate course: Those who are eligible for admission through special screening for foreigners, have graduated (or are expected to) graduate from a junior college, or have completed at least 2 years at a domestic or foreign university or a school with equivalent qualifications, and wish to transfer to the second or third year of our university.
 - Graduate school: Those who are eligible for admission through special screening for foreigners, have completed at least 1 semesters at a domestic or foreign graduate school or a school with equivalent qualifications.
 - Transfer grade/degree and recognized credits may be adjusted during the undergraduate and graduate school international transfer selection process.

III. Notice

- 1. The grades and evaluation details of the admission process are not disclosed
- 2. Submitted application and documents cannot be canceled or changed and will not be returned.
- 3. Self-introduction and academic plan must be written in Korean. (undergraduate applicants do not need to write a academic plan).
- 4. If you interfere with fair student selection by applying or cooperating through fraudulent methods, your admission may be invalidated and you may be subject to separate punishment.
- 5. All details of this recruitment guideline are not individually announced to applicants, so applicants must be fully familiar with the contents. All disadvantages arising from lack of acquaintance are the responsibility of the applicant.
- 6. All matters after admission are subject to the school regulations and related committee regulations.
- 7. In case of application at the counter, it is based on the time the university received the applicant's application. In case of mail application, it is based on the time when the mail is received by the university.
- 8. Applicants have an obligation to familiarize themselves with the detailed information regarding the announcement of successful applicants(schedule, notification method, other precautions, etc.) and confirm whether or not they have been accepted.
- 9. Applicants should always check related notices on the school website(www.hansei.ac.kr) and International Exchange Team's website(<http://hsiec.hansei.ac.kr>) during the admissions process and follow the instructions.
- 10. When submitting a portfolio(music major only), only songs in Italian, German, French, English, and Korean are accepted(songs in Chinese are not allowed).
- 11. Applicants must check the degree name of the department and major they are applying for. (Refer to the department and major information pages in the application guidelines).
- 12. Submitted documents will not be returned(if financial proof and other documents are required, obtain and prepare at least two copies).
- 13. Submission of documents and payment of admission fee must follow the procedures below.

14. If you are expected to graduate, submit a certificate of expected graduation or proof of enrollment (Submit a transcript as well) and then supplement the documents proving your final academic background by the date designated by the International Exchange Team(If not completed, your acceptance will be cancelled).
15. In the case of financial certificates, those residing in Korea can only submit proof of finances from a Korean account in their own name, while those residing overseas can submit proof of finances in their own name or their parents' name(However, please contact the consulate in charge of your area of residence to find out the period of proof of finances allowed when applying for a visa and it must be issued after inquiry)
16. Alien registration card holders must submit a copy of their alien registration card when submitting documents

IV. Graduation Requirements

1. International students must submit a report card of the Korean Language Proficiency Test (TOPIK) level 4 or higher (TOPIK level 3 or higher for arts and sports) valid until their graduation date to the school 30 days before their graduation date, and those who do not are not allowed to graduate. Alternatively, Documents proving the Ministry of Justice's social integration program (at least 81 points for completion or pre-evaluation) or King Sejong Institute's Korean language standard (intermediate 2nd degree) must be submitted to the International Exchange Team.
2. Students admitted through the international new (transfer) admission process must meet the class requirements set forth in the school regulations and enforcement regulations of the undergraduate and graduate schools.
3. Students admitted through the international new (transfer) admission process must meet other graduation requirements set by each department (major).

V. Method of screening applicants for admission

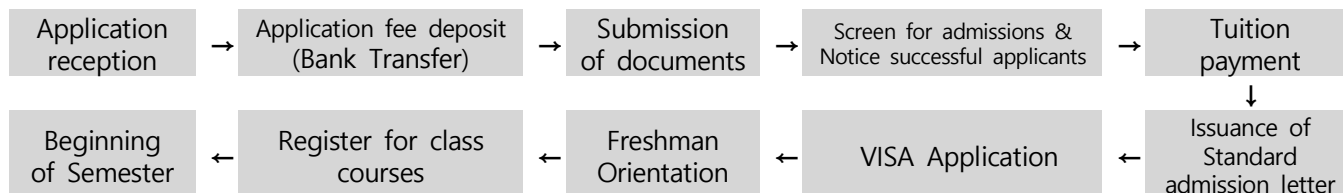
1. The details of the admission process for the special admission program for out-of-capacity foreign students shall be governed by the admission plan, selection procedure, and evaluation criteria for out-of-capacity foreign students established by the Management Committee of the Office of International Affairs.
2. Selection method : Document screening ⇨ Review by the admissions committee

4. Admission fee: KRW100,000 (all departments are the same)
 - ① The admission fee is transferred to the designated account (Industrial Bank of Korea/기업은행 471-010400-04-601, Account Holder: Hansei University)
 - ② The tuition deposit account will be announced individually later
 - ③ After the close of application, the application cannot be canceled, and the admission fee cannot be refunded.

VI. Admission process



1. Precautions for admission applicants
 - 1) If the minimum number of applicants for each major is not met during the tuition payment process after the announcement of the successful applicants, admission may be canceled and tuition may be refunded.
(Applicable standards are based on the standards of each semester's recruitment unit undergraduate and graduate school)
 - 2) Applicants may submit documents for admission by proxy, but they must be submitted within the deadline to be considered.
 - 3) The documents submitted by the applicant are used to screen the eligibility of the applicant, and only those who are eligible to apply will be screened for documents
 - 4) The contact information listed in the application form must be contactable until the end of the selection process, and the university is not responsible for any disadvantages arising from the loss of contact due to incorrect or changed phone numbers, e-mail addresses, etc.
 - 5) The university is not responsible for any disadvantages (such as cancellation of admission) incurred by applicants due to mistakes in the application form, lack of required documents, or non-fulfillment of procedures for entering Korea.
 - 6) Anyone who cheats in the entrance examination process shall be invalidated and rejected regardless of their grades.
 - 7) If it is confirmed that a student has been admitted or enrolled through fraudulent means, the admission or enrollment shall be canceled even after admission. (Admission will be canceled even after admission if there is a reason for disqualification of the applicant's qualifications through academic background checks, etc.)
